WHEREAS, the Board of Ferry County Commissioners previously has resolved to call for the formation of a county coalition to be formed by the counties of the Upper Columbia River area; and

WHEREAS, the Boards of Commissioners of other contiguous counties in the Upper Columbia River area have resolved to call for the formation of such a coalition; and

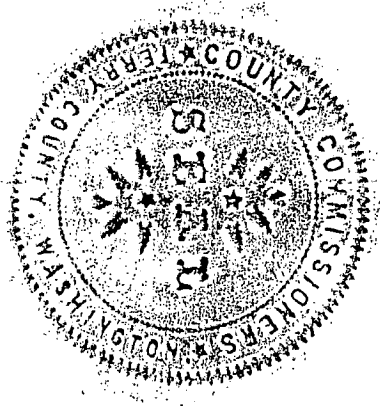
WHEREAS, all Boards find that the counties have a shared objective to protect the health, safety and welfare of their citizens; and
