Registration and check-in will begin at 8:30 am at the Colville City Swimming Pool parking lot (corner of S. Elm and Dominion Streets). Directions will be given for parade line-up at that time. Floats should be lined up by 9:00 am and all other entries by 9:30 am. The parade will begin at 10:00 am sharp.

Instructions on parade route will be given at registration time. Length of the parade is approximately one mile.

### **The following rules must be obeyed:**

1. **Nothing will be thrown from the parade entries...all items must be passed out along the side of the street.**
2. All entries must have an entry form filled out and returned by Thursday, August 25th. Late entries will be accepted at the Colville City Pool Parking Lot the morning of the parade. Late entries will be given slots near the end of the parade.
3. All entries must pick up a card with their assigned number at Parade Registration located at the Colville City Pool Parking Lot on the corner of S. Elm and Dominion Streets. Numbers will be given out the day of the parade and need to be attached to the unit.
4. The parade committee will not furnish parade transportation for visiting Royalty.
5. If you are an **equestrian group and there are more than 2 horses, you are responsible for furnishing your own "Pooper Scooper"!** No exceptions! All horses will stay off the grass and walkways going to and returning from the parade.
