WHEREAS, RCW Chapter 36.34 provides authority and a procedure for disposing of county property; AND  
 WHEREAS, the Stevens County Commissioners find that the surplus county property described on Exhibit 1 attached hereto and incorporated by this reference is no longer needed by Stevens County; AND

WHEREAS, the Board finds notice of the county's intention to dispose of the above surplus property has been published for two successive weeks in the legal newspaper of general circulation in the county as required by RCW 36.34.020; AND

WHEREAS, the Board finds that a hearing was held at 9:45 a.m. on Tuesday, September 7, 2010, in Room 214, Stevens County Courthouse; 215 South Oak; Colville, Washington, at the Board's usual place of business, and an opportunity for evidence to be submitted for and against the propriety and advisability of the proposed disposal was provided; AND

WHEREAS, the Board finds it is in the best interests of the citizens of Stevens County to sell the above-described surplus property;


NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Commissioners of Stevens County, Washington that:

1. The surplus county property described on Exhibit 1 is not needed by Stevens County.
2. The above property shall be disposed of for cash only at public auction to the highest and best bidder. The auction shall be held on **Friday, October 1, 2010 at 1:00 p.m.** with viewing one hour prior to the auction, at the Stevens County Sheriff's Impound Yard located at 179 DeGrief Road, Colville, Washington. *Provided*, Stevens County reserves the right to dispose of any items listed through the intergovernmental transfer process prior to the auction date. Additionally, the County reserves the right to remove any item from the surplus list at any time prior to the sale date and time.
3. The minimum sale price, if any, shall be as shown on Exhibit 1.
4. The Clerk of the Board is authorized and required to spread these findings and determination upon the minutes of the Board of Stevens County Commissioners and make them a matter of record. The Clerk is further authorized and directed to publish notice of sale as required by law.

Passed by the Board of Stevens County Commissioners meeting in regular session at Colville, Washington, by the following vote, then signed by its membership and attested to by its Clerk in authorization of such passage the 7<sup>th</sup> day of September, 2010.


