WHEREAS, in accordance with R.C.W. 36.33A.0440, rates for the rental of equipment owned by the Equipment Rental and Revolving Fund should be set to cover the full cost of operating and maintaining the equipment, and may include the cost of future equipment replacement; and

WHEREAS, the County Engineer has recently revised the equipment rental rates to more accurately account for increasing replacement costs due to material shortages, cost increases from equipment manufacturers and current high demand for construction related equipment, and;

WHEREAS, the 2011 rental rates were set previously by resolution for such equipment; and

WHEREAS, the attached revised 2011 rates consider the actual full cost of operating and maintaining the equipment, and will include a proportional increase toward the cost of future equipment replacement.

NOW, THEREFORE, BE IT RESOLVED by the Board of Stevens County Commissioners that the revised Equipment Rental Rate schedule as attached hereto is hereby adopted, will be effective July 1, 2011, and shall supersede all such prior Equipment Rental Rate schedules.

Passed by the Board of County Commissioners meeting in regular session at Colville, Washington, by the following vote, then signed by its membership and attested to by its Clerk in authorization of such passage the 27th day of June 2011.


