Agencies, tribes, and the public are encouraged to review and comment on the proposed application. SEPA will be completed after the close of the 30 day SEPA comment Period. SEPA Comments must be received by Thursday, September 2nd, 2010. After the close of the 30 day SEPA comment period, a threshold determination will be made. An Open Record Hearing on the proposed amendment is scheduled before the Stevens County Planning Commission on Thursday, October 14, 2010 at 9:00am, County Courthouse, Room 215. Comments on the proposed amendment must be received prior to the close of the open Record Hearing to be considered by the Planning Commission as they make a recommendation to the Stevens County Board of County Commissioners. Comments on the amendment will be accepted until the Stevens County Board of County Commissioners closes the record as part of their Open Record Hearing on this docketed application. The Board of County Commissioners has not set a Hearing date at this time.
